Notice for the purposes of Section 42(1)(b) of the Waste Management Acts 1996 to 2011 -  
Review by Agency of Waste Licence

Dear Mr O'Regan,

I am to advise, in accordance with Section 42(1)(b) of the Waste Management Acts, that the Agency intends initiating a review of your existing waste licence **W0255-01**, for a facility located at **Tulligmore, Dripsey, County Cork**.

The review is being initiated to bring your licence into compliance with recent amendments to legislation including those Statutory Instruments listed below:

- (1) European Communities Environmental Objectives (Surface Waters) Regulations 2009
- (2) European Communities Environmental Objectives (Groundwater) Regulations 2010
- (3) Waste Management (Management of Waste from the Extractive Industries) Regulations 2009

In accordance with Article 16(3)(i) of the Waste Management (Licensing) Regulations, you are required to submit the information and data contained in the **Review Form** at the following link: [http://www.epa.ie/downloads/forms/lic/ea/name\\_30839.en.html](http://www.epa.ie/downloads/forms/lic/ea/name_30839.en.html). The Agency may in due course seek further information from you in relation to the requirements of the legislation listed above and in particular, item 3.

In reference to item 3 above, a fee(s) is payable to the Agency for a review under Regulation 7(1)(d) of the Waste Management (Management of Waste from the Extractive Industries) Regulations, 2009. Please refer to the Waste Management Act (Licensing) Regulations 2004 to 2011, for fee details.

You may apply for a partial refund of fees but any such request will not be considered by the Agency until such time as a final decision has issued on the review.



**Please submit one signed original, one hardcopy and 2 copies on CD-ROM in electronic searchable PDF format by 1<sup>st</sup> September.**


For the purposes of the review, the reference number in the Register of Licences is No. **W0255-02**.

On 30<sup>th</sup> June 2011, a newspaper notice will be published in the Irish Independent in accordance with Article 10(1) of the Waste Management (Licensing) Regulations, stating that the EPA is initiating a review of your licence.

**Submissions**

In accordance with Article 10 of the Waste Management (Licensing) Regulations 2004 to 2011, you are entitled but not required to make a submission within one month of the date of this notice i.e. by 29<sup>th</sup> July 2011.
