re: <u>Waste Licence Application in respect of Murphy Environmental Hollywood Ltd at Murphy Environmental Hollywood Limited, Hollywood Great, Nags Head, The Naul, County Dublin</u>

Dear Mr Bell

I refer to the above referenced application for a waste licence which was received by the Agency on 17 December 2010 in respect of a landfill development proposed for the site of an existing inert landfill in north County Dublin. The proposal was recently granted planning permission by An Bord Pleanála in respect of the development which includes:

- redevelopment of an existing inert landfill;
- development of a new non-hazardous waste landfill:
- development of a new hazardous waste landfill:
- development of a hazardous waste treatment (immobilisation) facility to pretreat waste for the hazardous waste landfill; and
- installation of leachate, surface water and other landfill management infrastructure.

In addition, the development will involve the construction of a new administration building, car park and ancillary infrastructure; a new facility entrance and access road; and landscaping, wetlands and a biodiversity area.

I am to advise you that any person may make a submission to the Agency, in writing, in respect of the application, pursuant to Article 15 of the Regulations, which provides as follows:



Extract from the Waste Management (Licensing) Regulations

Submissions to the Agency regarding applications.

- 15. For the purpose of Section 40(2)(b) of the Acts, a person may make a written submission to the Agency in relation to -
 - (i) an application, and
 - (ii) such plans, documents and other information and particulars, including an environmental impact statement, as are submitted by the applicant in accordance with articles 12, 13, 14 and 16.

and the Agency shall not give notice of a proposed decision under section 42(2) of the Acts before the expiry of a period of one month following the date of a relevant

- (a) acknowledgement in accordance with Article 14(2)(a), or
- (b) notice in accordance with Article 16(2)(a), or
- (c) acknowledgement in accordance with Article 16(4).

The Agency will have regard to any submission made in accordance with the Regulations and will write, in due course, to each person who makes such a submission, to advise them of the Agency's proposed decision on the application.
