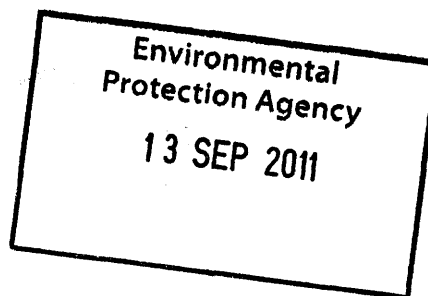

Dear Sir/Madam:

Due to certain corporate restructuring within Pfizer, we are writing to advise you of a technical change in the ownership of our facility. The proposed transferee is to a new incorporated company Pfizer Nutritionals Ireland Limited which will become effective from 28 October 2011.

Accordingly, enclosed please find:

- an original and 1 hard copy and 2 electronic (PDF) copies of a completed Transfer of a Licence Application Form for the transfer of Licence Register Number P0395-02 from 'Pfizer Ireland Pharmaceuticals' to Pfizer Nutritionals Ireland Limited.
- A cheque for €2000 for the IPPC Licence Transfer Application.

As requested in sections C(b) and C(d) of the application form, we have included a letter of acceptance (dated 26/08/11) from the Agency's Office of Enforcement, for both the Environmental Liabilities Risk Assessment (ELRA) and the Closure Restoration and Aftercare Management Plan (CRAMP) which were submitted earlier in 2011. The letter advised that the proposed form of financial provision associated with both documents will be dealt with under separate correspondence.

The proposed form of financial provision, a Form of Guarantee, was submitted to the Agency in advance of this transfer of licence application on 22/08/11 for approval (in accordance with section C(f)). This was followed-up with phone calls to the Agency to enquire after the
