re: Notice in accordance with Article 14(2)(b)(ii) of the Waste Management (Licensing) Regulations

Dear Mr.Leahy,

I am to refer to the above referenced application for a waste licence relating to a facility at Greenport Environmental Limited, Durnish, Harbour Road, Foynes, County Limerick. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 and Article 13 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

ARTICLE 12 COMPLIANCE REQUIREMENTS

- 1) Provide a copy of the agreement with Atlantic Fuel Supply Company to discharge treated sanitary effluent to their privately owned sewer.
- 2) Provide updated information, as appropriate, to demonstrate that Greenport Environmental Limited is a fit and proper person under Section 40(4)(d) of the Waste Management Acts 1996-2011. In particular, you should provide information to demonstrate that the person is likely to be in a position to meet any financial commitments or liabilities that may have been or will be entered into or incurred in carrying on the activity to which the application relates or in consequence of ceasing to carry out that activity.

ARTICLE 13 COMPLIANCE REQUIREMENTS

1) Where necessary update the EIS documents, having regard to the information requested under 'Article 12 Compliance Requirements' above.



Your reply to this notice should include a revised non-technical summary (Application Form and EIS) which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information in the form of a one (1) original plus one (1) copy in hardcopy format within one month of the date of this notice. In addition submit sixteen (16) copies of the requested information to the Agency in electronic searchable PDF format on CD-ROM. Please note that all maps/drawings should not exceed A3 in size.
