Ceased Licence Memo

SUBJECT:	Propose to Cease Licence Waste Licence Reg. No W0157-01

1. RECOMMENDATION

As the carrying on of the activity to which Waste Licence Reg. No. W0157-01 relates has not been substantially commenced within a period of 7 years beginning on the date on which the licence was granted, I recommend the following:

1. That the OEE issue a letter of notification to the Licensee under Section 49(1) of the Waste Management Act 1996, as amended stating that the licence has ceased to have effect from 17th November 2011 and the activity cannot now commence under this licence.
2. That the OEE notifies Cork County Council of the above.
3. That the OEE make the relevant amendments to the OEE database and notifies the other internal offices [OCLR, Accounts] to reflect the change in the licence's status to Ceased.

3. FACILITY LOCATION

The facility is located at Ballyguyroe North Co. Cork.

4. FACILITY HISTORY

The facility was granted a licence by the Agency on 17th November 2004. A number of planning applications were made by the licensee to Cork County Council for development of the site. These applications were subsequently refused by both Cork County Council and on appeal to An Bord Pleanala.

An application was made to the Agency by the Licensee on the 10th August 2007, under Section 49 of the Waste Management Act 1996 as amended, seeking an extension to the duration of the licence. An extension until 17th November 2010 was granted by the Agency.

A further application was made to the Agency on 24th August 2010 to again extend the duration of the licence for a further three years. An extension of one year until 17th November 2011 was granted by the Agency on 17th November 2010.

It is noted that the licensee has not made any application to extend the licence further.

5. CONDITION OF SITE

Other Environmental Liabilities: <i>Not applicable.</i>


6. AGENCY'S ASSESSMENT
