Re.: Notice in accordance with Regulation 18(3)(b) of the Waste Water Discharge (Authorisation) Regulations 2007

Dear Mr O'Keeffe

I am to refer to the above referenced application for a waste water discharge licence relating to the agglomeration named Cloughduv. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Regulation 16 of the Waste Water Discharge (Authorisation) Regulations 2007.

You are therefore requested, in accordance with Regulation 18(3)(b) of the regulations, to take the steps to supply the information detailed below:

REGULATION 16 COMPLIANCE REQUIREMENTS

- 1) Provide an updated map of the agglomeration boundary to include the primary discharge point (SW01), the waste water treatment plant and all parts of the waste water works, e.g. additional sewer pipe connections. Update any drawings where applicable.
- 2) Clarify the capacity and design storage period of the storm water holding tank located at the Cloughduv Waste Water Treatment Plant.
- 3) Clarify, where possible, in what circumstances and at what flow rates the storm water overflow located at the inlet works of the waste water treatment plant will operate and clarify in what circumstances the storm water overflow from the storm water holding tank will operate.

- 4) Provide the national grid reference of the primary discharge sampling/ monitoring point.
- 5) Confirm whether an EIS was required as part of the planning approval process for Cloughduv waste water works.


Your reply to this notice should include a revised non-technical summary which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information in the form of a one original plus one copy by **12th January 2012**. In addition please submit one copy of the requested information in electronic searchable PDF format on a CD-ROM (no file to exceed 10MB) to the Agency. Please note that all maps/drawings should not exceed A3 in size.
