Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. W0054-02 granted on 1/8/2003 and amended on 20/10/2005 and 9/11/2010, as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Acts 1996 to 2011.

Technical Amendment

In pursuance of the powers conferred on it by Section 42B(1)(c) of the Waste Management Acts 1996 to 2011, the Agency amends Licence Reg. No. W0054-02, granted to Eco-Safe Systems Limited, Unit 1A, Allied Industrial Estate, Kylemore Road, Ballyfermot, Dublin 10.

Henceforth, the licence shall be read in conjunction with Amendment A issued on 20/10/2005 and Amendment B issued on 9/11/2010 and the amendments set out below.

This technical amendment is limited to the following Schedule/Condition:

Conditions of Licence

5.3.6 Waste Storage Plan

- (a) No later than 31 January 2012, the licensee shall prepare a Waste Storage Plan for the facility. The Plan shall provide for storage of all waste at the facility, regardless of retention time, and shall, for each designated storage area, including container parking areas, describe:
- the waste types acceptable, taking into account the requirements of condition 3.14 of this licence and the specific hazards of the materials;
 - the maximum quantity of waste permitted to be stored at any one time, expressed in terms appropriate to the storage area and the waste stored, i.e. volume, number of drums/IBCs/road-containers, etc.;
 - the maximum stacking height of containers including drums and IBCs;
 - provision for access to each stored container of waste; and
 - other matters as may be directed by the Agency.
- (b) The Waste Storage Plan shall be maintained in a manner agreed by the Agency and shall be reviewed and revised annually or more frequently to reflect waste storage practices at the facility.



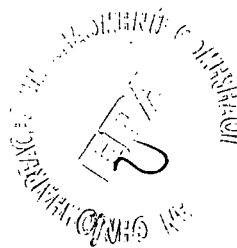
