Re: Application to withdraw waste water discharge licence applications submitted for the agglomerations Annyalla DO465-01, Doohamlet DO473-01 and Scotshouse DO446-01.

Dear Sir/Madam,

I refer to the applications submitted for waste water discharge licences for the agglomerations of Annyalla D0465-01, Doohamlet D0473-01 and Scotshouse D0446-01, to request that they be withdrawn on the basis that the current population equivalent is less than 500 p.e.

The applications submitted for the three agglomerations were based on the design capacity population equivalent of the waste water treatment plants and not the current treated domestic effluent p.e. of the plants, which are all under 500 p.e. outlined as follows:

Agglomeration:	WWTP design p.e.	Current treated p.e.
Annyalla	600 p.e.	200 p.e.
Doohamlet	600 p.e.	255 p.e.
Scotshouse	600 p.e.	300 p.e.

The projected population equivalent for the next 6 years for the agglomerations is not expected to reach 500 p.e. Based on this information, Monaghan County Council wishes to revoke these 3 discharge licence applications and request that the associated fees be returned. Applications for Certificates of Authorisation for the 3 agglomerations will be submitted in due course.


