Regulations

Dear Mr. Crowley,

I am to refer to the above referenced application for a waste licence relating to a facility at Country Clean Recycling Limited., Churchfield Industrial Estate, John F. Connolly Rd, County Cork. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 and Article 13 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

ARTICLE 12 AND ARTICLE 13 COMPLIANCE REQUIREMENTS

1. Assess the likelihood of significant effects of emissions from the Country Clean Recycling Limited facility on any European Site, designated under the EU Habitats Directive (92/43/EEC) and/or Birds Directive (79/409/EEC).

Carry out a Stage 1 Screening to determine if an Appropriate Assessment is required. Please refer to the document 'Appropriate Assessment of Plans and Projects in Ireland - Guidance for Planning Authorities', issued in 2009 by the Department of the Environment, Heritage and Local Government, and revised in 2010. Where based on the Stage 1 screening it is considered that an Appropriate Assessment is not required, provide a reasoned response. If following the Stage 1 Screening, an Appropriate Assessment is deemed necessary, then this shall be carried out and a Natura Impact Statement submitted accordingly.

Your reply to this notice should include a revised non-technical summary (Application Form and EIS) which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

It is not sufficient to annotate the original drawing with a textual correction. Please supply the information in the form of a one (1) original plus one (1) copy in hardcopy format by 21st February 2012. In addition submit sixteen (16) copies of the requested information to the Agency in electronic searchable PDF format on CD-ROM. Please note that all maps/drawings should not exceed A3 in size.
