To whom it may concern,

On checking your website we became aware of the following submissions from a Director of BioCore Environmental Limited AD1.

Our understanding that AdPower Roscommon Limited were a 100% subsidiary of BioPower Limited now we are led to believe that they are part of a new company BioCore Environmental Limited AD1 with this in mind we now believe that BioCore Environmental AD1 are determined to receive a waste licence for the plant in Ballinphuill although the original application was under the name AdPower Limited/BioPower and also that the EPA refused change of name to BioCore in April 2011.

We have noted from the CRO website dated the 4<sup>th</sup> December 2011 that AdPower Limited is still listed under the address of 55 Ailesbury Road, Ballsbridge, Dublin, which is also the address for BioPower Limited. From your website we have noted a letter from Mr. Flynn (Director of BioCore Environmental AD1) Solicitor stating an application to register a change in the situation of the registered office of the company has previously been lodged with the CRO but to date no change.

With all these differences within the companies can we trust any of these companies to run such a plant in our area. We would also like to mention that we don't need this kind of facility as Ireland is going to overshoot its green energy of 40% by 2020 (Irish Times 2010).

We hope you will take our concerns into consideration when making a decision on this application.
