I am to advise that in accordance with the provisions of Section 90(7) of the EPA Acts 1992 to 2011, you are requested to supply the following additional information so that the Agency may complete a comprehensive assessment:

- Confirm your class of activity i.e. 7.2.1 or 7.2.2.
- Provide a plan of the installation that identifies all storm water emission points and
  process emission point including the backwash discharge from the water treatment
  plant. Describe the catchment of each storm water emission point i.e. yards, roofs,
  car park etc. Provide details of oil interceptors and grit traps installed at the
  installation. Give details of any cooling water or other process related emission
  discharged to the surface water drainage system.
- For each storm water emission point give a unique emission point reference number and grid references for a monitoring location and discharge location.
- In relation to the process emission from the water treatment plant (backwash discharge), complete Table B.1 (i), (ii), Table C.1 (i) and Table C.2(i) and Section D of the review form.
- Provide orthophosphate monitoring results for the previous twelve months for SW1, where available.

In the circumstances you should make immediate arrangements to have the required information (1 signed original, 1 hardcopy and 2 copies of all files in electronic searchable PDF format on CD-ROM) submitted to the Agency without delay. Your response to this request should be directed to Sonja Smith Administration Officer, Office of Climate, Licensing & Resource Use.

It should be noted that where there is failure to comply with the above requirements within **one month** of this notice, the Agency may proceed with its consideration of this review in the absence of the information requested.
