

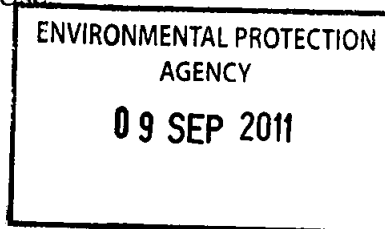

RE: Request for Technical Amendment – Greenstar Ltd – Gorey, Co Wexford W0220-01

Dear Sir,

Greenstar Ltd. (Greenstar) intends to install a new weighbridge at their waste recovery facility in Gorey, County Wexford (W0220-01). The proposed location of the weighbridge is shown on the enclosed Drawing 04822-01 and it is proposed to position it outside the area of the current licence boundary.

The provision of the new weighbridge is in response to Agency observations in audit reports (Your Ref W0220-01sm03br) that the existing weighbridge is too small to accommodate the larger vehicles used to consign wastes from the facility. The new weighbridge can accommodate all vehicle types accessing the site and will be connected to the weighbridge software system (WIMS) currently in operation at the facility for recording waste movements into and exiting the facility.

Due to the size of the weighbridge and the layout of the site entrance, the weighbridge can not practically be accommodated within the current licence area predominantly for Health & Safety and manoeuvrability reasons. In order to allow the installation of the weighbridge Greenstar, under Section 42B(1)(c) of the Waste Management Acts 1996-2010, requests a technical amendment of Condition 1.5 of the Licence to extend the licence area by 170m² so as to include the footprint of the new weighbridge. The proposed amendment to the licence area is shown on Drawing 04822-01 and the existing licence area is also delineated. The proposed extension area is currently exclusively used by vehicles accessing the facility.

The installation of the new weighbridge will not result in any of the requirements of Section 83(5) of the Waste Management Acts 1996-2010 not being satisfied. A letter of consent from the site landowner is enclosed.
