

Re: Waterford City Council - Waste Licence Licence Reg. Nr. WO 244-01

Dear Ms. Doris.

Further to the meeting held on June 25th 2009, we confirm that the following are the correct maximum and average daily emission volumes from both OCU1 and OCU2 that we wish to have included in the Waste Licence.

OCU1

Average / Dav

Maximum / Day

331,560m^{3/} / day 381,000m^{3/} / day

OCU₂

Average / Day

142,819m^{3/} / day

Maximum / Day

164,000m^{3/} / day

We reiterate that these changes do not impact negatively on the predicted odour emissions from the site. Please refer to Schedule B1 of the Waste Licence.

We also confirm that there is a slight deviation from Condition 6.16.3 (ii). The buildings as a whole are not maintained under a negative pressure. Rather, the sources of odour are individually enclosed and maintained under a negative pressure and extracted via the odour control units.

We request a technical amendment to the licence conditions to reflect these points.
