To whom it concerns.

Under schedule A of our waste licence W0261-01. Panda are permitted to accept 50,000 tonnes per annum (until necessary infrastructure is in place) comprising 40,000 tonnes per annum of Mixed C&D and 10,000 tonnes per annum Mixed Dry Recyclables, Commercial & Industrial, Paper & Cardboard into this facility.

Under our current licence, we can increase our overall tonnage to 200,000 tonnes per annum when the necessary infrastructure in place. This overall increase allows us to increase our C&D tonnage to 75,000 in the building currently being used. We recently received permission from the Agency to store baled Cardboard, baled Plastic and boxed clothes hangers outside at the facility as per our proposal dated the 23rd September 2011 and OEE's reply dated the 6th October 2011. Therefore, by storing this tonnage outdoors in a manner that will not cause any nuisance we have additional storage space for additional mixed C&D waste streams in the current building.

Under out current run-rate, we will exceed our licenced limit by circa 12,000 tonnes. We currently have accepted 48,000 tonnes for the year to date. This extra volume of material is more than capable of being handled in our existing building, as we are only transferring this waste from this facility and not processing any waste. We hope to increase our licenced tonnage to 62,000 tonnes per annum for the 2011 reporting period.

- Mixed C&D increased to 49,000 tonnes per annum.
- Paper, Cardboard and Plastic increase to 13,000 tonnes per annum.

There will not be any increase or changes in emissions associated with this increase in tonnage of mixed C&D, Paper, Cardboard and Plastic.

We are requesting as to whether this tonnage increase can be considered under a Technical Amendment. I enclose correspondence from the Mr. Niall Horgan (OEE Inspector for the facility) with regards this proposal.
