Re: Notice in accordance with Article 16(1) of the Waste Management (Licensing) Regulations

Dear Mr. Hedigan,

I am to refer to the above referenced application for a waste licence relating to a facility at Clean (Ire) Refuse & Recycling Ltd., Ballinagun West, Cree, County Clare and to thank you for submitting the necessary information which has enabled the Agency to confirm that the application complies with the requirements of Articles 12 and 13 of the relevant Waste Management (Licensing) Regulations.

The stage has now been reached where the Agency is giving detailed consideration to the application and to complete this task the following information, particulars and evidence are required in accordance with Article 16(1) of the Regulations.

Please provide complete answers to each question.

ARTICLE 16(1) - FURTHER INFORMATION, PARTICULARS AND EVIDENCE

- 1. Having regard to the fact that Belmullet Meteorological Station is located approximately 170 km from the installation and that there are other meteorological stations in closer proximity to the facility, provide reasoning for using meteorological data from the Belmullet Station in the air dispersion model.
- 2. State whether there will be other parameters, beside Nitrogen Dioxide, Carbon Monoxide and Sulphur Dioxide, emitted from CHP plant. Provide an air dispersion modelling assessment for each of these parameters and update Section E.1: *Emissions to Atmosphere* of the Application Form to reflect the emission of any parameters not previously identified.
- 3. Table F.2.2 of the information dated 23 February 2012 shows the location of the proposed stack in county Cork. Re-submit the grid reference numbers for the proposed stack.
- 4. Clarify whether the proposed stack height of 14 m is height from the ground level to the top of the stack or from a top of a building to the top of the stack. State whether the modelling takes the cumulative height into account.
- 5. Provide a copy of the planning permission for the proposed works, including the proposed CHP plant stack, and the corresponding planning inspector's report.





In the case where any drawings already submitted are subject to revision consequent on this request for further information, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Your reply to this notice should include a revised non-technical summary (EIS and Application Form), which reflects the further information you supply in compliance with the notice, insofar as that information impinges on the relevant non-technical summary.

Please supply the information in the form of a one original plus one copy within **four weeks** of the date of this notice. In addition submit sixteen copies of the requested information to the Agency in electronic searchable PDF format on CD-ROM. Please note that all maps/drawings should not exceed A3 in size.
