Westland Horticulture IPPC Licence Application (P0914-01) Peat extraction near Lough Derrayaragh SPA, Co. Westmeath

To Whom It May Concern:

In respect of the above-mentioned IPPC licence application, we are writing to you further to: the <u>Department of the Environment's submission of 21 June 2010</u>; <u>my submission of 3 August 2010</u> (in the name of Friends of the Irish Environment); and <u>my submission of 14 February 2012</u> (also in the name of Friends of the Irish Environment), this final submission relating primarily to Bulrush Horticulture Ltd's ongoing IPPC application (renumbered P0974-01; formerly P0599-02), but highlighting issues of direct relevance to this application, given the proximity of Westland's and Bulrush's operations in Co. Westmeath.

We note the EPA's recent decision - almost three years after the present application was lodged - to subject this licence application to an environmental impact assessment pursuant to the EIA Directive (Directive 85/337/EFC) recently codified as Directive 2011/92/EU). An Taisce is surprised and concerned, however, that the EPA has not screened for (and then carried out) an appropriate assessment of 'in combination' effects on the Lough Derravaragh Special Protection Area (SPA) for birds as part of this licence application, pursuant to the Habitats Directive (Directive 92/43/EEC) and the European Communities (Birds and Natural Habitats) Regulations 2011 (No. 477/2011).

For the reasons set out in full in the above-mentioned submissions, such an assessment is required as a matter of law. (Note that the Department of the Environment's submission cited above explicitly supports this view.) We should therefore be grateful for your confirmation in writing that an appropriate assessment of 'in combination' effects on Lough Derravaragh SPA will be carried out in respect of this licence application.
