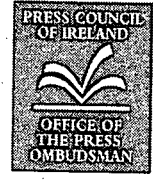

The Agency granted an IPPC licence, subject to conditions, on 10th June 2013, to Ballyfaskin Enterprises Limited, Ballyfaskin, Ballylanders, County Limerick, Reg. No. P0915-01, for Class 6.2: the rearing of pigs in an installation, whether within the same complex or within 100 metres of the same complex, where the capacity exceeds 2000 places for the production of pigs and 285 places for sows in an integrated unit, at Ballyfaskin, Ballylanders, County Limerick. National Grid Reference 262406E 162457N. A person shall not question the validity of the decision of the Agency other than by way of an application for judicial review and any such application or any other legal proceedings must, in accordance with Section 87(10) of the EPA Acts, as amended, be instituted within the period of eight weeks beginning on the date of the giving of the decision. 
