Dear Sir/Madam

Planning permission has been granted for the overall development Planning Ref P09/1270 for extension to existing structures and new builds to accommodate new waste processes; one such process requires the installation of exhaust stack (at the rear of the Biostabilisation Building at the southern boundary) arising from the biogas combined heat power engine. The proposed stack height at time of granting of planning permission was 8m high. Last year the EPA requested an air dispersion model on the emissions from the CHP engine, which concluded that an increase in stack height from 8m to 14m will be required. Currently the stack has not been constructed/commissioned, and this part of the development will not be undertaken in 2013.

The EPA are eager to confirm whether the extension to stack height should constitute exempted development or require planning permission before granting the Waste Licence. I have reviewed other waste licences that have been exempted for similar proposed changes and would like to confirm if this proposed change from 8m to 14m CHP stack constitutes exempted development under the Planning and Development Regulations 2001 which states that under Class 21 (iii):

(a) Development of the following descriptions, carried out by an industrial undertaker on land occupied and used by such undertaker for the carrying on, and for the purposes of, any industrial process, or on land used as a dock, harbour or quay for the purposes of any industrial undertaking—(iii) the installation or erection by way of addition or replacement of plant or machinery, or structures of the nature of plant or machinery with the condition

The height of any plant or machinery, or any structure in the nature of plant or machinery, shall not exceed 15 metres above ground level or the height of the plant, machinery or structure replaced, whichever is the greater.

I would be grateful if you could advise on the above at your earliest convenience.
