re: <u>Notice in accordance with Article 16(1) of the Waste Management (Licensing)</u> <u>Regulations</u>

Dear Mr Jones

I am to refer to the above referenced application for a review of a waste licence relating to a facility at Indaver Ireland Limited (Duleek), Carranstown, Duleek, Meath. This notice is given under Article 16(1) of the Waste Management (Licensing) Regulations, to enable the Agency to decide on the application.

Please provide complete answers to each question.

ARTICLE 16(1) - FURTHER INFORMATION, PARTICULARS AND EVIDENCE

- 1. The Environmental Licensing Programme is minded to form the view and make a recommendation that that the inclusion of the disposal activity code D10 in a waste licence is necessary if Indaver Ireland Limited is to be authorised to accept waste for disposal by incineration. If the D10 class of operations is not included as part of the licence application, this may restrict the types of wastes the facility will be able to accept. Please act on one of items (a) or (b) below.
 - a. If the D10 activity is not to be sought for inclusion in a waste licence, state the minimum calorific value for waste streams to be accepted that is sufficient to ensure the incineration of individual waste streams constitutes recovery as defined in article 3(15) of Directive 2008/98/EC.
 - b. If the D10 activity is to be sought for inclusion in a waste licence, you are required to do the following:
 - Revise Section B of the waste licence application to include D10 for waste streams that are to be accepted for disposal;
 - re-publish the newspaper notice and erect a new site notice;





• notify the planning authority of all the relevant classes of activity proposed in the licence application,

in line with the requirements of Articles 5, 6, 7, 8 and 9 of the Waste Management (Licensing) Regulations 2004, as amended.

- 2. Justify that the use of the laboratory in Indaver's Dublin Port facility, or other accredited laboratory, will conform to the requirements of BAT as per the IPPC reference document on Best Available Techniques for Waste Incineration (2006) regarding laboratory requirements for the incineration of hazardous wastes and clinical wastes.
- 3. Explain how Indaver will determine and demonstrate that the hazardous waste proposed to be accepted at the facility is low level hazardous waste and therefore suitable for incineration at the Carranstown facility.
- 4. Explain how Indaver will conform to Specific BAT for clinical waste incineration Section 5.6 (80), regarding washing out of waste containers, and how it will manage any potential effluent arising from doing so.

In the case where any drawings already submitted are subject to revision consequent on this request for further information, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Your reply to this notice should include a revised non-technical summary (EIS and Application Form), which reflects the further information you supply in compliance with the notice, insofar as that information impinges on the relevant non-technical summary.

Please supply the information in the form of a one original plus two copies within **four** weeks of the date of this notice. In addition submit sixteen copies of the requested information to the Agency in electronic searchable PDF format on CD-ROM. Please note that all maps/drawings should not exceed A3 in size.
