Hi Dara,

The Board have requested clarification on the status of the interceptor at the Country Clean Recycling Limited facility.

Condition 3.18 (ii) of the W0257-01 RD refers to the interceptor on the storm water discharge from yard areas and reads:

"An oil separator on the storm water discharges from yard areas. The separator shall be a Class I by-pass separator."

The requirement for the installation of an oil interceptor for the run-off from yard areas is included in the recent planning permission from Cork City Council, in relation to the expansion of the existing facility (T.P. 09/33682). The specific planning permission condition states that "Runoff from yards shall be routed through a suitable bypass interceptor/silt trap in accordance with IS EN 858-2:2003...". This interceptor is not currently in place.

As the run-off from yard areas discharge to Cork City Council's storm water sewer, it is appropriate for the oil separator to be Class II rather than Class I. Therefore I consider it appropriate for Condition 3.18 (ii) to be amended, as requested by the Board, to read:

"An oil separator on the storm water discharges from yard areas. The separator shall be a Class II by-pass separator."

Please advise if you require any further clarification.
