The EPA has recently issued Waste Water Discharge Licences for agglomerations in County Cork, namely *Boherbue & Environs*, and *Ballyhooley & Environs*. The EPA is writing to inform you that it is the responsibility of Cork County Council, as the licensee, under Condition 6 of the Waste Water Discharge Licences to ensure that notifications, records and reports are submitted to the EPA in accordance with the requirements of the licences.

In order to facilitate prompt and efficient reporting to the EPA all licensees are required to submit incident notifications to the EPA via the incident notification web-form at '*Manage My Waste Water Discharge Authorisations*' on the EDEN website (www.edenireland.ie). General correspondence relating to the waste water discharge licences, such as requests to amend the location, frequency or scope of monitoring, should also be submitted to the EPA on the EDEN website as a licensee return.

- The EPA audit template to be used during waste water audits.
