I refer to your application for a waste water discharge licence relating to agglomeration named Monaghan.

REGULATION 16 COMPLIANCE REQUIREMENTS

Question

Please confirm that all the all wastewater entering the WWTP is treated by the post-1994 works on-site (i.e. the activated sludge treatment system) and that no wastewater is diverted to the pre-1994 works (i.e. the percolation filter system).

MCC confirm that the pre 1994 works are not currently used for the waste water treatment process on site, nor have they been from the beginning.

Question

Describe under what circumstances an overflow occurs for each of the overflows in the agglomeration. Confirm if these overflows are storm water overflows and/or emergency overflows. Note that emergency overflows include overflow mechanisms constructed as part of pump sump infrastructure, whereby a power failure, essential maintenance or other similar interruption in normal operations results in a discharge of untreated waste water from the sump as a consequence of the pumps being disabled - discharges resulting from insufficient hydraulic capacity within the system are not regarded as emergency discharges.
