The term "pre-treatment" is not defined in the Industrial Emissions Directive. The term "treatment" is defined in the Waste Framework Directive (2008/98/EC) as:

recovery or disposal operations, including preparation prior to recovery or disposal^{*}.

The term 'treatment' has the same meaning as 'pre-treatment'

Waste licence applicants will have already selected applicable recovery and disposal activities in their waste licence applications (section B.7 of the waste licence application form) that they have sought for authorisation. As a general rule, it is appropriate that any of

these activities followed by dispatch of the waste for incineration or co-incineration should be regarded as "pre-treatment of waste for incineration or co-incineration" for the purposes of the new First Schedule.

Clarification of any considerations of "capacity" taken into account when completing the Registration Form:

The Drumman facility will have a capacity of 99,000 tonnes per annum (tpa). It is envisaged that c. 50,000 tonnes of input material will comprise mixed dry recyclables and c. 49,000 tonnes will comprise C&D/C&I material.

Under planning granted by Offaly Co. Co. (10/93), the facility can operate for 18 hours per day (06:00 to 00:00) and for 6 days per week (Monday to Saturday inclusive), resulting in 312 available working days.

In relation to the First Schedule activity 11.4 (b)(ii), operating on a 6 day per week basis:

99,000 / 312 operating days = 317 connes per day

Thus exceeding the applicable threshold of 75 tonnes per day for 11.4 (b).

In relation to activity 11.6, it is considered that the facility has the legal and technical ability to provide temporary storage capacity greater than 50 tonnes thus exceeding the capacity threshold (as per the *Guidance in Interpretation and Determination of Capacity under the IPPC Directive*).
