In relation to the above Waste Licence Application, we submit additional unsolicited information, on behalf of the Applicant, as follows:

Site Management


1. A number of changes have been made to the staffing structure since the Waste Licence Application was lodged with the Agency in December 2010¹.
2. The current staffing structure is as follows:
 - The Facility Manager at Hollywood is Kathryn Moonan.
 - The Deputy Facility Manager is Emma Murphy.
 - Rory Murphy is the Operations Manager and has responsibility for directing and controlling incoming vehicles and waste placement in restoration areas.
 - The directors of MEHL are: Rory Murphy, Emma Murphy and John Fortune (Non-Executive Director).
 - The company is further supported by its consultant teams for specific engineering, technical and scientific requirements.

3. MEHL is cognisant of the significant transition in terms of operations, control and management skill that will be required to change from an inert site to an integrated waste management facility, which operates inert, non-hazardous and hazardous landfill cells. It is also recognised that staff resources at the Hollywood facility have become depleted in recent years, due to the economic downturn, and the collapse of the construction sector, in particular, which has impacted on business activity at the existing inert landfill (W0129-02).
4. In the context of W0129-03 and the establishment of a new integrated waste management facility, MEHL recognises the requirement to re-build its staffing and management structures at the facility, to ensure the development and operation of an effective and compliant facility. To this end, MEHL will recruit additional staff with the requisite technical knowledge or qualifications to operate the facility and comply with the EPA Waste Licence.
5. The facility's management team and operational staff will be competent on the basis of education, skills, training and experience. Specialist consultancy expertise will be acquired, as appropriate.
6. New staffing structures, as well as financial provision and related commitments, will be put in place by the licensee prior to the commencement of waste activities under any amended Waste Licence.
