

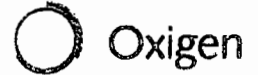
It is noted that you have not responded to this notice issued in accordance with Article 14(2)(b)(ii) of the relevant Waste Management (Licensing) Regulations.
