I refer to the Agency's your most recent letter of 09th January 2014 for an extension of time regarding the determination of licence now revised to 18th May 2014, which is a further revision on the Agency's letter of 09th December 2013 where a determination was due 19th January 2014 from the Agency.


We are extremely disappointed on these further delays given our application was submitted 03rd May 2012.

These delays are making it difficult to plan the programme, we have pre-qualified contractors and have an invitation to tender ready to issue on determination of the licence, changing delivery dates for licence determination pose challenges regarding resources on the project.

It is also our understanding that additional work may be required to comply with recent changes to legislation (with the introduction of the EPA (Industrial Emissions) (Licensing) Regulations 2013) including a baseline survey, re-erection of Site Notices etc. We would appreciate if the amount of additional work required was minimised to expedite the proposed determination.

We would request that all efforts are made to avoid any further delays to the project and therefore approve the extend time period for a determination to 18th May 2014.
