Re: Notice in accordance with Section 42 (II)(b) of the Waste Management Act 1996-2013 as inserted by SI No. 505 of 2013

Dear Sirs

I am to refer to the above regulations and the above referenced application for a waste licence received on 13/11/2008 relating to a facility at Wolfestown, Eadestown, Naas, Co. Kildare.

In accordance with Section 40 (2A)(C) of the Waste Management Acts (1996-2013), the Agency has assessed the information submitted and considers that the application must be made subject to an environmental impact assessment (EIA).

Therefore in accordance with Section 42 (II)(b) of the Waste Management Acts (1996-2013), you are requested to take the steps and supply the information detailed below:

SECTION 42 (II)(b) COMPLIANCE REQUIREMENTS

Submit an Environmental Impact Statement (EIS) within 16 weeks of the date of this letter. The EIS should be prepared in light of the Agency's guidance documents on EIS, which are available at the following link:
<http://www.epa.ie/downloads/advice/ea/guidelines/>

Please be advised that if you **fail to submit** an EIS within the period specified above, or any additional period as may be specified by the Agency, the application for a licence **shall be deemed to be withdrawn**.



You should note that applications for activities which are on-going and licensable cannot be withdrawn and any applications of this nature that are deemed to be withdrawn will be referred to the Office of Environmental Enforcement for investigation and possible enforcement action. You should consult with the Agency before letting your application be deemed to be withdrawn. This will relate in particular to facilities where the total intake of waste at the facility since waste activities commenced has exceeded 100,000 tonnes and where the facility has not been closed in accordance with a waste facility permit and to the satisfaction of the local authority that issued the permit.

In addition to the above, please be advised that you are required to erect a site notice, publish a newspaper notice and notify the planning authority in accordance with Article 6, 7 and 9 of the Waste Management (Licensing) Regulations 2004. The purpose of the revised notices is to advise of the preparation of an EIS in relation to the activity. A copy of the relevant notices must be submitted with the EIS, as per the Regulations.

Please supply the information outlined above in the form of a one (1) original plus one (1) copy in hardcopy format. In addition please submit two (2) copies of the requested information in electronic searchable PDF format on a CD-ROM to the Agency. Please note that all maps/drawings should not exceed A3 in size.
