TRANSFER OF A WASTE LICENCE

Decision of the Agency, under Section 47(5) of the Waste Management Act 1996 as amended

Waste Licence Register No: **W0173-01**

The Agency, in exercise of the powers conferred on it by the Waste Management Act 1996 as amended, for the reasons hereinafter set out, hereby transfers waste licence register number W0173-01 from Greenstar Environmental Services Limited, Ballymount Cross, Tallaght, Dublin 24, to Starrus Eco Holdings Limited, Unit 6 Ballyogan Business Park, Ballyogan Road, Sandyford, Dublin 18, CRO Number 527552. Waste Licence Register No W0173-01 licenses the carrying on of the waste activities set out below at Greenstar Environmental Services Limited (Kinsale Road), Forge Hill, Kinsale Road, County Cork, subject to twelve Conditions, as set out in the waste licence.

Licensed Waste Disposal Activities in accordance with the Third Schedule to the Waste Management Act 1996 as amended

Class 11.	Blending or mixture prior to submission to any activity referred to in a preceding paragraph of this Schedule. Reason: This activity is limited to bulking and transfer of waste prior to disposal off site.
Class 12.	Repackaging prior to submission to any activity referred to in a preceding paragraph of this Schedule. Reason: This activity is limited to the compaction and repackaging of waste prior to disposal off site.
Class 13.	Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned is produced. Reason: This activity is limited to storage prior to bulking and transfer of waste prior to disposal off site.

Licensed Waste Disposal Activities in accordance with the Fourth Schedule to the Waste Management Act 1996 as amended

Class 2.	Recycling or reclamation of organic substances which are not used as solvents (including composting and other biological transformation)

This activity is limited to the recovery and storage of organic waste prior to recovery off-site.

Class 3. Recycling or reclamation of metals and metal compounds:

This activity is limited to the storage of metals prior to recovery off-site.

Class 4. Recycling or reclamation of other inorganic materials:

This activity is limited to the storage of inorganic materials prior to recovery off-site.

Class 12. Exchange of waste for submission to any activity referred to in a preceding paragraph of this Schedule:

This activity is limited to the exchange of waste for further recovery off-site.

Class 13. Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where such waste is produced:

This activity is limited to the storage of waste prior to recovery.


In accordance with Section 47(6) of the Acts, Starrus Eco Holdings Limited is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, that may arise.

REASONS FOR THE DECISION

Pursuant to Section 47(5)(a) of the Acts, the Agency is satisfied, on the basis of the information available, that Starrus Eco Holdings Limited is entitled to be regarded as a fit and proper person to be granted a like waste licence. Pursuant to Section 47(5)(b) of the Acts, the Agency is satisfied, on the basis of the information available, that Starrus Eco Holdings Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the programme officer's report.
