## WASTE MANAGEMENT ACT 1996 as amended

## TRANSFER OF A WASTE LICENCE

Decision of the Agency, under Section 47(5) of the Waste Management Act 1996 as amended

Waste Licence Register No: W0136-03

The Agency, in exercise of the powers conferred on it by the Waste Management Act 1996 as amended, for the reasons hereinafter set out, hereby transfers waste licence register number W0136-03 from Greenstar Recycling (Munster) Limited, Sarsfieldcourt Industrial Estate, Sarsfieldcourt, Glanmire, Cork to Starrus Eco Holdings Limited, Unit 6 Ballyogan Business Park, Ballyogan Road, Sandyford, Dublin 18, CRO Number 527552. Waste Licence Register No W0136-03 licenses the carrying on of the waste activities set out below at Greenstar Recycling (Munster) Limited, Sarsfieldcourt Industrial Estate, Sarsfieldcourt, Glanmire, County Cork subject to twelve Conditions, as set out in the waste licence.

Licensed Waste Recovery Activities, in accordance with the Fourth Schedule of the Waste Management Act 1996, as amended.

Class R 3. (Principal activity)	Recycling /reclamation of organic substances which are not used as solvents (including composting and other biological transformation processes), which includes gasification and pyrolysis using the components as chemicals.
Class R 4.	Recycling/reclamation of metals and metal compounds.
Class R 5.	Recycling/reclamation of other inorganic materials, which includes soil cleaning resulting in recovery of the soil and recycling of inorganic construction materials.
Class R 13.	Storage of waste pending any of the operations numbered R 1 to R 12 (excluding temporary storage (being preliminary storage according to the definition of 'collection' in section 5(1)), pending collection, on the site where the waste is produced).



## Licensed Waste Disposal Activities, in accordance with the Third Schedule of the Waste Management Act 1996, as amended.

Class D 13. Blending or mixing prior to submission to any of the operations numbered D 1 to D 12 (if there is no other D code appropriate, this can include preliminary operations prior to disposal including pre-processing such as, amongst others, sorting, crushing, compacting, pelletising, drying, shredding, conditioning or seperating prior to submission to any of the operations numbered D1 to D12).

Class D 14. Repackaging prior to submission to any of the operations numbered D 1 to D 13.

Class D 15 Storage pending any of the operations numbered D 1 to D 14 (excluding temporary storage (being preliminary storage according to the definition of "collection" in section 5(1), pending collection on the site where the waste is produced.

In accordance with Section 47(6) of the Acts, Starrus Eco Holdings Limited is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, that may arise.

## REASONS FOR THE DECISION

Pursuant to Section 47(5)(a) of the Acts, the Agency is satisfied, on the basis of the information available, that Starrus Eco Holdings Limited is entitled to be regarded as a fit and proper person to be granted a like waste licence. Pursuant to Section 47(5)(b) of the Acts, the Agency is satisfied, on the basis of the information available, that Starrus Eco Holdings Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the programme officer's report.
