**Re: Waste Licence Transfer Application Forms**

Dear Sirs

As you may be aware, Starrus Holdings Limited, an Irish company, ("**Starrus**") has recently entered into an exclusive agreement with the Receiver of Greenstar Holdings Limited ("**Greenstar**") to purchase certain assets representing substantially all of the waste management activity of Greenstar, with the exception of landfills ("**Non-landfill Transaction**"). To complete the proposed Non-Landfill Transaction, we are seeking to transfer the Waste Licences in respect of the 12 facilities (**Appendix 1**) belonging to Greenstar (or one of its subsidiaries) to Starrus Eco Holdings Limited which will ultimately become a subsidiary of Starrus post completion of the transaction.

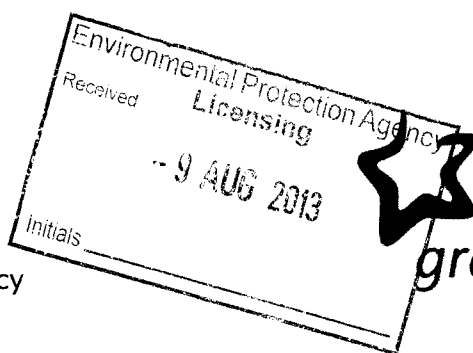
This sale process is scheduled to complete in July 2013. No transfer to Starrus should be made before the licensee and the proposed transferee notify the Agency of the desired effective date.

Please find enclosed completed Waste Licence Transfer Application Forms (the "**Applications**") for your consideration (**Appendix 2**). The application fee of €60,000 will be submitted to the EPA upon receipt of the OEE approval letters required for the application process.

We understand that approval from the Office of Environmental Enforcement ("**OEE**") is required in respect of the ELRAs and CDPs and the related financial provision prior to submitting the Waste Licence transfer applications. Greenstar has recently submitted this information to the OEE. We further understand following our recent discussions with the EPA and our meeting with the EPA of 12 June 2013, that it has been agreed that we could submit the Applications to the EPA prior to receiving the aforementioned approval.

We would be grateful if the contents of this letter are kept confidential and not disclosed to third parties without the prior written consent of Starrus and Greenstar.


