I refer to your enquiry dated 7<sup>th</sup> March 2014 on behalf of the Recycling Village Ltd.

Having considered the information submitted on 3<sup>rd</sup> April 2014 ( which included WFP MH 11 0005 01) Meath Co Council considers that the proposed development which mirrors the activity licensed under the waste facility permit, with a maximum intake of not more than 15,000 tonnes, does not require a mandatory EIA. Furthermore the Council, is satisfied that the proposed development would not be likely to have significant effects on the environment and thus it is also determined that a sub threshold EIA is not required.

On a separate matter, the Recycling village should also satisfy itself that the use of the building for the purposes outlined is in accordance with the extant planning permissions on site.
