**NOTICE** is hereby given in accordance with Articles 5 and 6 of the Environmental Protection Agency (Industrial Emissions (Licensing) Regulations, 2013 (as amended) (SI No. 137 of 2013) that "Bord Gáis Éireann" having its principal offices at Gasworks Road, Cork, will apply for an Industrial Emissions Licence to the Environmental Protection Agency by the prescribed date in respect of land bounded by Dock Road to the north west, O'Curry Street to the north east and housing and light industry to the south east and south west in Limerick, otherwise known as "Former Limerick Gasworks" - National Grid Reference:-R 5694E, 5656N The works will comprise the remediation (clean up) of the Former Limerick Gasworks, involving pumping and treating of groundwater and stabilising soils, with associated recovery and disposal of non-hazardous and hazardous contaminated soils.

An Environmental Impact Statement has been previously submitted to the Agency in relation to a Waste Licence application (W0281-01).

The classes of activity as per the First Schedule of the EPA Acts 1992 to 2013 are:

11.1- The recovery or disposal of waste in a facility, within the meaning of the Act of 1996, which facility is connected or associated with another activity specified in this schedule in respect of which a licence or revised licence under Part IV is in force or in respect of which a licence under the said Part is or will be required.

11.2- Disposal or recovery of hazardous waste with a capacity exceeding 10 tonnes per day involving one or more of the following activities:  
(b) physio-chemical treatment;
