Dear Mr Naughton

I refer to your application for a licence review, which was received by the Agency on 24 April 2014

I am to advise in accordance with Regulation 10(2)(b)(ii) of the EPA (Industrial Emissions) (Licensing) Regulations 2013, that the following information is required in support of the application under Regulation 9 of the Regulations:

1. As required under Regulations 9(2)(g) and 9(2)(x), provide details on the storage arrangements and fire protection measures for RDF (refuse derived fuel) storage. This should include details of the maximum amount of RDF that will be stored on-site at any one time and the on-site locations for RDF storage. Clarify what level of fire risk assessment has been carried out for RDF storage and what are the associated fire prevention and protection measures. Clarify what access the licensee has to the shut-off valve for surface water discharges in the event of a fire, or provide details on what measures will be put in place to ensure the shut-off valve is accessible in the event of a fire.
2. As required under Regulation 9(2)(i), complete Tables E.1(ii) and E.1(iii) to include particulate emissions and maximum hourly flow rate for the odour abatement unit. Pre- and post- abated levels of particulate emissions should be provided.
3. As required under Regulation 9(2)(k)(i), clarify the height of the recycling building and confirm the building dimensions used in the odour dispersion model are consistent with the dimensions for the actual and proposed buildings.
4. As required under Regulation 9(2)(n), review the baseline report with respect to the, *European Commission Guidance concerning baseline reports under Article 22(2) of Directive 2010/75/EU on industrial emissions (2014/C 136/03)*, and submit an amended version accordingly.
5. As required under Regulation 9(2)(g), submit details of the Central Commercial District waste presentation by-laws that the licensee considers necessitate a change to the waste acceptance hours.

In addition to the above please also provide an updated non-technical summary to reflect the information provided in your reply.
