Notification under Section 42(1I)(e)(i) of the Waste Management Act 1996, as amended

Dear Director

I refer to previous correspondence in relation to a licence application.

Please note that a response to this notice is required even if you have no observations to make.


Where it is intended to submit additional documentation with your observations, it would be much appreciated if you could include an electronic copy of all documents in pdf format on a
