Dear Mr Somers

I refer to your letter received 17th June 2014 requesting the Agency to confirm whether the Industrial Emissions (IE) licence associated with the above referenced site will need to be reviewed to accommodate the development proposed in Planning Application reference No: 17.PM0004.

The Industrial Emissions (IE) Licence for Indaver Ireland Limited is currently under review (Register No: W0167-03). The licence review application and an EIS were received on the 23rd April 2012 and may be viewed on the Agency's website www.epa.ie. Please note that while a waste licence application was made in the first instance, the proposed activity is now an Industrial Emissions Directive (IED) activity under the EPA Act and the application will therefore be processed under the IE licensing regime.

As outlined in our previous letter to An Bord Pleanala, dated 1st August 2012, in relation to planning application 17.PA0026, the licence review application W0167-03 was originally made for an increase in annual throughput of waste to 220,000 tonnes per annum. It is noted that the alteration to which planning application 17.PM0004 refers seeks to increase the waste throughput to 235,000 tonnes per annum. The applicant has informed the Agency of this proposed tonnage increase and that increase will be considered as part of the current licence review application.

The proposed alteration does not substantially change the comments made by the Agency on the 1st August 2012 in relation to planning application 17.PA0026.
