

Dear Sirs,

We wish to draw the Agency's attention to the report of Geosyntec Consultants to the EPA dated June 2014 contained in the Agency's Inspectors Report on the MEHL application WO129-03, and referred to in the current Proposed Determination to refuse the license sought by MEHL.

We wish to draw the Agency's attention in particular to the short, medium, and long-term environmental hazards associated with the landfilling of untreated MSW incinerator bottom ash, identified by Dr. Marcus Ford, and to remind the Agency once again that the current Indaver application contains no proposal for bottom ash treatment, and clearly does not meet BAT standards.

The residents of Hollywood and District are appreciative of the care and attention given by the Agency to the MEHL application, but would be concerned that there appears to be no overall national policy for the treatment and disposal of incinerator bottom ash which meets current EU BAT standards.
