 Notice is hereby given in accordance with Articles 7 and 8 of the Waste Management (Facility Permit and Registration) Regulations 2007 that Carbon From Tyres Ireland (CFTI) Limited with an address at 107 Fendale, Navan, Co. Meath intends to apply for a Waste Facility Permit for the operation of a waste tyre recovery facility including using Thermolysis technology to recover carbon black, fuel oil and metal from waste tyres at premises located at Sites 1.2 & 3, Eamon Duggan Industrial Estate, Athboy Road, Trim, Co. Meath. The application for a waste facility permit will be made to Meath County Council within 10 working days of the date of this notice.  
 The classes of activity, in accordance with the Fourth schedule of the waste Management Act 1996, to be carried out at the facility is/are as follows:  
**Class (es) R3** (Principle Activity) Recycling/ Reclamation of organic substances which are not used as solvents (including composting and other biological transformation processes), which includes gasification and pyrolysis using the components as chemicals.  
**Class (es) R11** Use of waste obtained from any of the components numbered R1 to R10.  
**Class (es) R12** Exchange of waste for submission to any of the operations numbered R1 to R11 (if there is no other R code appropriate, this can include preliminary operations prior to recovery including pre-processing such as, amongst others, dismantling, sorting, crushing, compacting, pelletising, drying, shredding, conditioning, repackaging separating, blending or mixing prior to submission to any of the operations numbered R1 to R11).  
**Class (es) R13** Storage of waste pending any of the operations numbered R1 to R12 (excluding temporary storage [being preliminary storage according to the definition of 'collection' in section 5 (1)], pending collection, on the site where the waste is produced).  
 The Class of Activity in accordance with Part 1 of the Third Schedule of the Waste Management (Facility Permit and Registration) Regulations 2007, to be carried out at the facility is as follows:  
**Class 10** The recovery of waste (not mentioned elsewhere in this part of the third schedule), other than hazardous waste or an activity specified in Category 5 of Annex 1 of Council Directive 96/61/EC, where, -  
 (a) the annual intake does not exceed 50,000 tonnes, and  
 (b) the maximum quantity of residual waste consigned from the facility for onward transport and submission to disposal at an authorised facility shall not exceed 15% of the annual intake.

 Kierman Sand and Gravel Ltd, Foxtown Townland, Summerhill, County Meath intends to apply to the Environmental Protection Agency for a waste licence for the continued operation of a waste recovery facility on lands at Foxtown Townland, Summerhill, County Meath (National Grid Reference 285633E 253005N). The nature of the development is the continued phased restoration of a sand and gravel pit using imported inert soils, stone, and recovery of inert construction and demolition waste. Up to circa 40,000 cubic metres per annum of inert materials is being accepted to site.
