I refer to a letter dated 2/9/2010 received by the Agency on 3/9/2010 in relation to the proposed reduction in monitoring frequency of emissions to air and sewer and also the use of the Bruss internal laboratory for compliance monitoring at your facility.

I am to advise you that the proposal submitted is to the satisfaction of the Agency contingent on the following:

- The agreed frequencies are set out in the last column of Tables 1 and 2 below.

Table 1: Air monitoring Frequency:

Parameter	Current Frequency	Proposed Frequency	Agreed with Agency
Emissions to Atmosphere	Biannually	Once in 3 Years	Annually

Table 2: Sewer Monitoring Frequency:

The monitoring should be carried out at the frequencies agreed in the table above and all incidents should be reported to the Agency in accordance with Conditions 4.1& 11.2 of your IPPC Licence.
