Subject: Integrated Pollution Control (IPC) Licensing at G. BRUSS GmbH, DICHTUNGSTECHNIK, Finisklin Road, Sligo.

This letter is to advise Sligo County Council Planning that an application is being made to the Environmental Protection Agency for a review of the existing G. BRUSS GmbH Integrated Pollution Control Licence, PO 465-01, regulated under class 5.7 '.. the manufacture of Elastomers where capacity exceeds 1,000 litres per week' at our manufacturing site at Finisklin Road, Sligo (National Grid Reference E 168460, N 336322.

This review application is being submitted to accommodate a new coating process, 'Gleitmo Coating' as part of production activities. This process will give rise to an emission to atmosphere of VOC, proposed A2-5 emission point, which is not provided for under the conditions of our existing licence. Confirmation to this affect has been received by G. BRUSS from the Agency's Office of Environmental Enforcement, Castlebar.

A Planning Exemption Application, under Section 5 of the Planning and Development Act 2000, for the construction of a housing unit and associated venting stack was submitted, and exemption obtained, from Sligo County Council Planning in July of 2014.


