### Notification under Section 42(11)(e)(i) of the Waste Management Act 1996, as amended

Dear Secretary

I refer to previous correspondence in relation to a licence application.

The Agency has decided that an Environmental Impact Assessment (EIA) is required in relation to the activity concerned and on the 28<sup>th</sup> February 2014 the applicant was requested to submit an Environmental Impact Statement (EIS) under Section 42(11)(b) of the Waste Management Act 1996, as amended.
