Notification under Section 42(1I)(e)(i) of the Waste Management Act 1996, as amended

Dear Director of Services, Planning

I refer to previous correspondence in relation to a licence application.

The Agency has decided that an Environmental Impact Assessment (EIA) is required in relation to the activity concerned and on the 28th February 2014 the applicant was requested to submit an Environmental Impact Statement (EIS) under Section 42(1I)(b) of the Waste Management Act 1996, as amended. The EIS was received by the Agency on the 10th October 2014.




Please note that a response to this notice is required even if you have no observations to make.
