I am to refer to your incomplete application for a waste licence, Reg. No W0259-01 which was received by the Agency on 13/02/2009.

As you are aware, the Agency assessed your waste licence application for compliance with Article 12 and Article 13 of the relevant Waste Management (Licensing) Regulations, 2004 as amended and on 29 August 2011 and 28 February 2014, requested information under Article 14(2)(b)(ii) of the said regulations in order to complete the application.

None of the above information has been received by the Agency to date. The Agency is also advised by Limerick County Council that planning permission to extend the duration of the previous planning permission granted to raise the land levels at the site at Dock Road Limerick, has been refused. The Agency is now of the opinion that the waste licence application has been abandoned.

I enclose a Notice in accordance with Article 21(2) of the Waste Management (Licensing) Regulations, 2004 as amended. If no submission is received within the period specified in the notice, the application will be regarded as having been withdrawn.
