A Chara,

I refer to your letters dated 2<sup>nd</sup> September 2014 and 10<sup>th</sup> November 2014 re. the above and would respond as follows to the queries raised therein.

<u>Point 1</u>: The complaint reference Ballastpit, Pollardstown-PAE2014/34 notified by the Agency to the Council on the 7<sup>th</sup> April, 2014 refers to the same

site as Pollardstown Refuse Depot in the application for a Certificate of


Authorisation.

Point 2: As the site is used by the Transportation Section of the Council as a Roads Depot, information was obtained from existing and former staff in relation to the site from the 1000's

in relation to the site from the 1990's.

Street sweepings from Newbridge town had been disposed of at the depot during the 1990's, but an instruction was given to cease this practice in the late 1990's. From that time street sweepings were placed in a skip in Newbridge and disposed of to Silliot Hill landfill, which was now the central landfill for the county, as the former refuse tips in the county incl. Pollardstown, were then closed landfills. Material from local road and footpath maintenance may have gone to the depot up to the early 2000's. Since that time on occasion similar type material may have been deposited on site, however, if this did occur, it would not have involved the disposal of significant amounts of material and in recent years material was removed from the site and the overall site timed up.

The above is borne out by the results of the Tier 2 and Tier 3 environmental risk assessments carried out on the site during 2010. The detailed and extensive site investigations showed no level of methane or carbon dioxide in the 30 no. gas monitoring locations on the site and concluded that there was no evidence of impact on Pollardstown Fen from the site.

The Council is anxious to implement, as soon as possible, the remaining site remediation measures specified in the Tier 3 Report, i.e. planting of native trees and re-profiling of the surface and request that the application submitted for a certificate of authorisation be processed.
