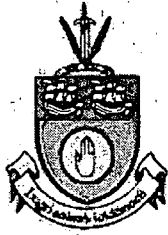

I refer to the above and the advertisement in The Irish Times dated 2nd December 2014 which states the time period for submitting an objection to the granting of a revised licence in respect of Indavar Ireland Limited, Carranstown, Duleek, Co Meath is 5th January 2015.

The Louth County Council, Planning & Environment Strategic Policy Committee which met on the 9th December, 2014 noted the short time-scales permitted on such applications and that the period for submission on the above application falls over the Christmas Holidays which in effect shortens the time period for submitting an objection.

The Chairperson and the Committee agreed that correspondence be sent to the EPA on the time scales for such applications under the current legislation and that these timescales be extended under the legislation to allow the public sufficient time to prepare and submit objections regarding this matter.
