Dear Mr Dowdall,

I refer to your application for a licence, which was received by the Agency on 4 November 2013.

I am to advise in accordance with Regulation 10(2)(b)(ii) of the EPA (Industrial Emissions) (Licensing) Regulations 2013, that the following information is required in support of the application under Regulation 9 of the Regulations:

1. Provide a site drawing that clearly illustrates and labels the boundary of proposed licensed installation.
2. Complete a BAT analysis which ensures all BAT Conclusions are covered and if an individual BAT conclusion is found to be not applicable please state this (Regulation 9(2)(h)).
3. As required by Regulation 9(2)(p) and to the relevant extent provide a description of any measures proposed to be taken to minimise pollution over long distances.
4. In order to allow the Agency to decide whether a Baseline Report is required in respect of the installation, provide a screening report prepared in accordance with the *Communication from the Commission – European Commission Guidance concerning baseline reports under Article 22(2) of Directive 2010/75/EU on industrial emissions (2014/C 136/03)* (Regulation 9(2)(n)).

In addition to the above please also provide an updated non-technical summary to reflect the information provided in your reply. The non-technical summary must meet the requirements of Section A of the Industrial Emissions Licence Application form, which is available on the Agency's website www.epa.ie.




The requested information should be submitted to the Agency within **4 weeks** of the date of this notice, in order to allow the Agency to process and determine your application.

In the circumstances, you should make immediate arrangements to have the required document(s) (1 signed original and 1 copy in hardcopy format, and 2 copies of all files in electronic searchable PDF format on CD-ROM) submitted to the Agency without delay. Your response to this request should be directed to Noleen Keavey, Administration Officer, Office of Climate, Licensing, Resources & Research.
