On behalf of my client Harvest Lodge Pigs ltd, who operate a pig farm at Gortnamuc, Kilcormac, Co Offaly. I herein request permission to review the existing IPPC Licence for the facility located at the same address (IPC Reg P0412-01) following discussions with Agency personnel.

The existing IPPC License was issued on 22 July 1999, under Class 6.2.0; Intensive Agriculture for "The rearing of pigs in installations, whether within the same complex or within 100 metres of that complex where the capacity exceeds 1,000 units on gley soils or 3,000 units on other soils and where units have the following equivalents- 1 pig = 1 unit, 1 sow = 10 units".

This IPPC License was Amended for the purposes of Section 82(11) and section 96(1)(c) of the EPA Acts 1992 to 2007, by notice from the Agency dated 14<sup>th</sup> October 2009.

The operating capacity of this farm is determined by Schedule 1(i) of the above referenced License, and provides for the stock numbers set out overleaf. This was effectively a breeding unit, but for commercial reasons must be developed into a full integrated unit, finishing stock to factory weight. As a result the breeding sow numbers will be reduced, to ensure production levels can be farmed to factory weight on site, in accordance with animal welfare regulations.

Therefore we request permission to review this IPPC License to properly reflect this alteration.

I am to advise that based on the information provided the Agency has determined that a review of your licence (Reg No. P0412-01 is necessary and that are application for a review should be submitted to the Agency in accordance with Section 90(1)(b) of the ERA Acts 1992 to 2011. This review is necessary in the light of:

• Your proposal to convert from a breeding unit to an integrated unit.

You should note that it will be the entire IPPC licence that will be subject to the review and the application and any submission should be prepared on this basis.

For the purposes of this review you are required to use the Agency's application form. The Application form is available to download from the Agency's website: <a href="http://www.epa.ie/downloads/forms/lic/ippc/">http://www.epa.ie/downloads/forms/lic/ippc/</a>. In particular you are required to include the following information:

- the maximum number of animals to be housed on-site (sows, gilts, production pigs etc.), having regard to the IPPC Directive definition of sow (including gilts following service) and production pig;
- an assessment of the impact of discharges/emissions from the activity; and
- consideration of Best Available Techniques for the activity.

I should also advise that in accordance with section 87(1)(a) of the EPA Acts 1992 to 2011 you are required to do the following:

Notify, in writing, the planning authority in whose functional area the activity is or will be situated, that an application is to be made to the Agency for the review of your existing licence or a revised licence under section 90 of the EPA Acts 1992 to 2011. Please forward a copy of this notification to the Agency with the information requested above, and;

o publish a notice advising that an application is to be made to the Agency for a review of your existing licence in a newspaper circulating in the district in which the activity is situated. You are requested to publish this notice within the period of two weeks before the submission of your application. Please forward a copy of this publication to the Agency with the information requested above.

All information and data should be submitted in the following format one original, 1 hard copies and 2 copies on CD-ROM in electronic searchable PDF format.

I am also to advise that your application is to be accompanied by the appropriate fee (as outlined in the EPA Licensing (Fees) Regulations).
