# 3. FACILITY LOCATION AND HISTORY

Ormande Organics Limited (the licensee) was granted planning permission by South Dublin County Council on 29/08/2007 (Pl. Ref. SD07N0528) for a hazardous waste facility. The 0.41 hectare site is located on the eastern boundary of Greenogue Industrial Estate. The licensee was granted waste licence Reg. No. W0237-01 on 08/09/2008 to accept and process up to 37,000 tonnes/year of hydrocarbon contaminated liquid and solid waste. Since the site was licensed it has been leased to third party commercial activities that did not relate to the licensed activity.

#### 4. AGENCY'S ASSESSMENT

Based on a site visit of Ormonde Organics Ltd. on the 14/09/2014 and an assessment of lease agreements, it was determined that the activity for which the facility was licensed did not substantially commence within a period of 3 years:
