I refer to your application for a licence.

I am to advise in accordance with Regulation 10(2)(b)(ii) of the EPA (Industrial Emissions) (Licensing) Regulations 2013, that the following information is required in support of the application under Regulation 9 of the Regulations:

1. Please provide a map which indicates the position at which the site notice dated 12<sup>th</sup> May 2015 was displayed. [Regulation 9(4)(d)(ii)]
2. Please provide the information below in order to fully address the requirements of Regulation 9(2)(e):
  - i. A copy of the grant of permission for Planning File Reference Number SA140011.
  - ii. A statement as to whether an EIS was submitted with the following planning applications or written confirmation from the Planning Authority that an EIA was not required, by or under the Act of 2000, for Planning File Reference Numbers: 014304, SA30347 and SA140429.
3. It has been confirmed that it is no longer intended to operate the Wright tunnels and the associated biofilter. It has also been confirmed that the waste processing equipment was relocated from Building 1 to Building 3.
  - Please confirm when you propose to decommission the Wright Tunnels and the associated biofilter.
  - Clarify what activities are proposed to take place in Building 1.[Regulation 9(2)(g)]
4. Clarify when the integrated constructed wetland is proposed to be operational.

5. In the correspondence received on the 12th May 2015 it was confirmed that the hazardous substances diesel and gas oil will be used at the installation.


In addition to the above please also provide an updated non-technical summary to reflect the information provided in your reply.
