In order to facilitate prompt and efficient reporting to the EPA all licensees are required to submit incident notifications to the EPA via the incident notification web-form at 'Manage My Waste Water Discharge Authorisations' on the EDEN website (www.edenireland.ie). General correspondence relating to the waste water discharge licence, such as requests to amend the location, frequency or scope of monitoring, should also be submitted to the EPA on the EDEN website as a licensee return.
