## **AA Screening Determination:**

That the activity is not directly connected with or necessary to the management of the site as a European site and that it cannot be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects will have a significant effect on a European site and accordingly determined that an Appropriate Assessment of the activity is required, and for this reason determined to require the applicant to submit a Natura Impact Statement.

- Monitoring results submitted by the applicant for surface water run-off discharge from the site show that this discharge is contaminated with parameters such as ammoniacal nitrogen, arsenic, calcium, chloride, chromium, lead and others.
- There is uncertainty about whether the contaminated run-off has potential to reach and impact the European Sites.
